FINAL JUDGMENT

In accordance with Rule 58 of the Hawai'i Rules of Civil Procedure, the Court hereby enters Final Judgment, as stated herein, based upon the verdict of the jury in the trial of this matter reached on May 26, 2011 and filed in open court at 4:26 p.m. on May 26, 2011 (the "Verdict"). The Verdict fully and finally resolved (1) the claim in the complaint in Civil No. 08-01-323K (the "Complaint") filed by Plaintiff Charles F. Hosley ("Plaintiff") on October 15, 2008 to quiet title to Grant 1596 to Pololi (the "Claim") against Defendant/Counterclaimant/Cross-Claimant Margaret A. Schattauer ("Schattauer"), (2) Schattauer's First Amended Counterclaim against Plaintiff, filed January 8, 2009, to quiet title to that portion of Grant 1652 to William Johnson ("Grant 1652") claimed by Plaintiff to be included within the boundaries of Grant 1596 to Pololi ("Grant 1596") as Grant 1596 was surveyed in 2008 by Chrystal Yamasaki of Wes Thomas Associates and described in Exhibit "A" to the Complaint, (3) Schattauer's First Amended Cross-Claim, filed February 14, 2011, (the "Cross-Claim") against Defendants Terry Muraki, James S. Taketa, Gary Taketa, and Helen M. K. Calip to quiet title to Grant 1652. as Grant 1652 is described in Exhibit "A" to the Cross-Claim, (4) Schattauer's Cross-Claim against Defendant Amy Ka to quiet title to Grant 1652, as Grant 1652 is described in Exhibit "A" to the Cross-Claim, by reason of the Stipulation Between Defendant/ Counterclaimant/Cross-Claimant Margaret A. 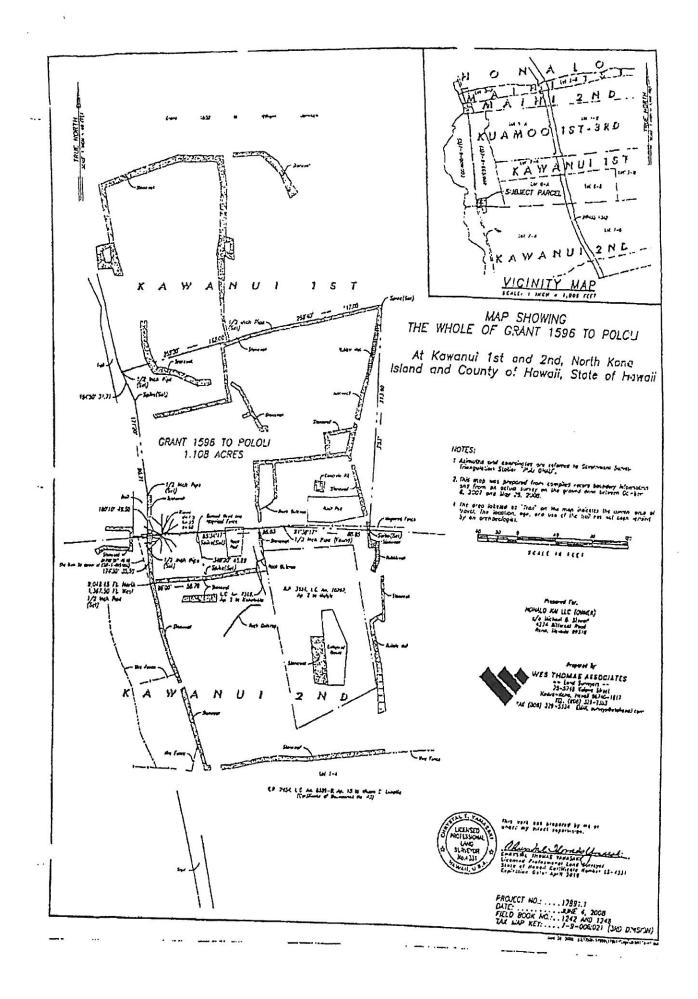
